I. Reports

1. Secretary's Report: Minutes from the 1/08/15 meeting were entered. Hakkinen motioned to accept the minutes, Loughlin seconded. Minutes accepted unanimously.

2. Treasurer's Report:

A revised 1/8/15 Treasurer's Report was handed out along with the present report. The current statement reflects the activity on Council's checking account for the months of January - April 2015.

Loughlin requested more information in this report such as current bank and check details. Antipas may be looking to switch banks due to monthly maintenance fees.

3. Comcast Report: In Codeanne's absence Kelley passed out the report with community relations and marketing updates.

4. SEC-TV Report: Facchini reported on the 25 programs currently being produced.

5. TVC Report: Shelton reported on video upgrades, programming updates and community relations. Hakkinen asked about plant expansion, Shelton said no plans for expansion is firm at this time.

II. Old Business

1. Increase/Review membership:
Motion was made by Loughlin: All Advisory board members will recruit for all member towns and BOEs, but each member should have the lead responsibility for his own town and Board of Education. Suggested recruiting with recent graduates, particularly Electrical Engineering and Science (list of recent UCONN graduates were handed out). Hakkinen seconded. Passed unanimously.
2. Status of CTACSC Information Video Production for Public Access: due to production staff shortages, taping should start mid-end of June.
3. Loughlin made a motion regarding a previous topic on self-education of advisory board members: All advisory board members must devote some time between meetings to self-education and open communications. No one seconded the motion. Motion failed. Members felt this is an accepted philosophy but cannot be mandated.

III. New Business

1. Effect of live streaming: No one at meeting to address this important topic.
2. Election of officers: Antipas, the nominating committee chair presented the following slate:

Bill Hakkinen Vice-Chair
Shawn Greeley Secretary
Dean Antipas Treasurer

Anitpas made the motion to accept nominations, Palmeri seconded. Loughlin nominated himself as Chairman.

Vote for Chairman: 1 vote for Loughlin, 4 votes for Kelley. Kelley is Chairman.

Rest of the positions were uncontested, passed unanimously.

IV. Communications

Kelley: A letter was received and a handout titled Upcoming Contract Renewals was passed out.

Loughlin: Asked how often the board mailbox was checked. Kelley answered, about every month and a half. Kelley will give a key to Loughlin to check this more often if he wishes. After discussions on communications via email, Kelley repeated that no deliberating via email should ever occur.

Loughlin made a motion to have a meeting in July. No one seconded it. Motion failed.

Palmeri, Antipas & Hakkinen: Nothing to communicate.
